INTRODUCTION

Mexico is the cradle of the genus Agave and its biodiversity. Agave cultivation and use has cultural, economic, and environmental importance not only to produce alcoholic beverages such as tequila, mezcal and sotol, but also to use of the plant and its by-products, such as syrups, fructans, fibers, fodder, wood, etc.

In Oaxaca, mezcal agro-industry plays an important role since it generates 128,000 direct and indirect jobs annually. Currently, and due to the rise in the demand for mezcal, there is an overexploitation of the different species of agaves, which has led to the predation of wild species, and endangers the extinction of endemic ones. In addition, its monoculture in forest soil slopes is causing a serious environmental problem.

Considering the experience of CIIDIR Oaxaca organizing the two previous National Congresses of Agave and Mezcal, held in 2017 and 2019, respectively, this time, together with the 3rd National Congress, we will hold the 1st International Congress of Agave and Mezcal to exchange experiences with researchers, international organizations officials, entrepreneurs from other countries with sectors related to this value chain.

Given the current and potential use of this natural resource of Mexico, the 3rd National Congress and 1st International Congress aims to contribute to the knowledge, use and sustainable management of agaves and mezcal agro-industry, through the dissemination of research carried out in various public and private institutions, in addition to the dissemination of empirical knowledge of the producers involved in agave cultivation, exploitation, transformation and commercialization.
